1. Purpose

1.1 The purpose of the report is to:

- Request approval for a capital scheme to be included in the Council's capital programme for 2008-09.
- Request approval for a capital scheme to be included in the Council's capital programme for 2009-10.

2. Recommendations

2.1 That Cabinet approve the following scheme to be included in the capital programme for 2008-09.

3. Issues and Choices

3.1 Report Background

- 3.1.1 The latest approved capital programme for 2008-09 was approved by Cabinet on 18th March 2009.
- 3.1.2 The latest approved capital programme for 2009-10 was approved by Cabinet on 7th April 2009.

Approval of Capital Project

- 3.1.3 Approval is sought for the following scheme to be included in the Councils 2008-09 capital programme.
 - 2008-09/GF085 Mounts Baths Changing Bench Replacement
- 3.1.4 The purchase of the changing benches at Mounts Baths has been funded from revenue in 2008-09.
- 3.1.5 It was essential that the benches were purchased as the existing plastic units had become unsafe and were removed from the changing areas to prevent them being a hazard to the public. A capital appraisal form has been completed to formalise the movement of this expenditure into the 2008-09 capital programme.
- 3.1.6 Approval is sought for the following scheme to be included in the Council's 2009-10 capital programme.
 - 2009-10/GF058 Glass Recycling
- 3.1.7 This project is to be funded by a revenue contribution in 2009-10. Glass recycling collections formed part of the revenue budget options and were approved by Council on 26th February 2009. The purchase of these boxes is capital expenditure and as such approval is sought for the scheme to be included in the 2009/10 capital programme.
- 3.1.8 Further details of the schemes are given in Annex A (Project Appraisals).
- 3.1.9 The proposals put forward for approval with this report have been submitted as capital project appraisals, which have been signed off by, amongst others, the relevant Corporate Director, the Section 151 Officer and the appropriate Cabinet Portfolio Holders. A copy of the capital project appraisal forms, which are listed as background papers, are available on request.
- 3.1.10 All schemes in the capital programmes, whether included in the original programmes, arising from slippage, or added to the programme during the year, are fully funded, either from borrowing, internal resources or from external funding arrangements.
- 3.1.11 The total approved programme for 2008-09 will increase by £12.4k along with the associated financing as a result of the project appraisals brought with this report. The latest approved programme with this addition is set out in the table below:

- 4.2.2 Any revenue budget implications related to the capital projects are set out in the capital project appraisals, and fed into revenue budget planning as appropriate (i.e. through revenue budget monitoring, budget build or medium term financial planning).
