Who is involved in Scrutiny

Up to 2005 the Council had seven separate Overview and Scrutiny Committees, each reflecting a portfolio.

As part of the Constitutional changes made in September 2005 this was streamlined down to a single Committee, supported by various ad hoc task and finish groups. Whilst this has proved effective, it has been difficult to maintain the necessary breadth of overview across the range of the Council's activities.

In May 2007, the number of Overview Scrutiny Committees was increased to three, in addition to a Scrutiny Management Committee.





Who is involved in Scrutiny contd.

The Committees mirror the Executive portfolios and are identified as O&S1 (Partnerships, Regeneration; Community Safety and Engagement) O&S2 (Housing and Environment) and O&S3 (Improvement, Performance and Finance). The Overview and Scrutiny Management Committee comprises six Members who will normally be the Chairs and Deputy Chairs of the three Overview and Scrutiny Committees. Its responsibilities include:



Monitoring Overview and Scrutiny Reviews

The Overview and Scrutiny Committees monitor the implementation and effectiveness of the recommendations made in Task and Finish Groups' reports at future meetings. The timetable is detailed in the Overview and Scrutiny Monitoring Work Programme 2007/2008 which can be found on the Overview and Scrutiny pages of the Council's website www.northampton.gov.uk/scrutiny

Task and Finish Groups

The Overview and Scrutiny Committees set up time limited Task and Finish Groups to carry out important reviews, which then make focussed valuable, recommendations to Cabinet.

The most recent reviews to be submitted to Cabinet at its meeting on 2 July 2007 were:-

- Street Scene Abandoned vehicles and the implications of the Clean Neighbourhood Act 2005
- Leisure Services Council's Leisure Services
- Homelessness (Rough Sleepers) To further develop the multi Agency approach to rough sleeping
- Evaluation of Dispersal Orders To add value to the Dispersal Order process

Cabinet received all of the above reports and commented that consideration would be given to the recommendations bearing in mind budgetary issues. A report will be made back to the appropriate Overview and Scrutiny Committee in the autumn 2007.

্ব Task and Finish Group Work

The following Task and Finish Groups started their reviews in July 2007 and are due to report their findings to the appropriate Overview and Scrutiny Committee in the autumn:-

Community Engagement Task and Finish Group

This Task and Finish Group was set up to review the Council's engagement activities, including Neighbourhood Management and to review how community engagement can be improved and what Groups the Council should be engaging with, in particular how it should engage with new communities not currently represented. The Task and Finish Group held its initial meeting in July to scope its review and agreed that it would collate its evidence by a variety of methods, including interviews with internal witnesses and receiving written evidence from external witnesses, looking at models of best practice and carrying out desktop research. The information gathered will contribute to the Task and Finish Group's final report which will be presented to Overview and Scrutiny Committee 1 at its meeting on 12 September 2007.

Voluntary Sector Task and Finish Group

This Task and Finish Group is reviewing how it can make recommendations arising from the review to Cabinet to assist in the budget process and medium tern financial strategy for 2008 2011, the organisations currently being funded and the overall Voluntary Community Sector partnership strategy against the national situation of funding. It held its scoping meeting in July and will gather evidence by carrying out desktop research, interviewing internal and external witnesses and collating statistics and data. The Chair will present the final report to Overview and Scrutiny Committee 1 on 12 September 2007.

Reporting and Monitoring Task and Finish Group

Overview and Scrutiny Committee 3 set up this Task and Finish Group to review the Council's reporting and monitoring mechanisms. The initial scoping meeting was held in July and the evidence that would be gathered to form its review was agreed. The Task and Finish Group's final report will be presented to Overview and Scrutiny Committee 3 at its meeting on 10 October 2007.







Northampton's Overview and Scrutiny process noted for best practice

The Borough Council's Overview and Scrutiny Committee has been noted for best practice on a few issues over the past year or so.

The Homelessness Review (2005/2006) was well received by external scrutiny peers, for example, the report was commended by Wycombe District Council's Scrutiny Commission who was due to carry out a review on the same topic. The Local Authority's Lead Scrutiny Councillor and Scrutiny Support Officer met with the Homelessness Task and Finish Group and relevant Northampton Borough Council employees to look at areas of best practice that will inform its review. This information was included in the Borough Council's Overview and Scrutiny Annual Report 2005/2006.

Recently, the Scrutiny Officer from Wycombe District Council met with the Borough's Scrutiny Officer to obtain details of this Council's Overview and Scrutiny's monitoring process as currently Wycombe District Council does not have such a process in place.

The Borough Council recently hosted a seminar on the Local Government White Paper and Bill, which was attended by many local authorities and facilitated by Gareth Wall, of the Centre for Public Scrutiny.

During discussion with Councillor Brendan Glynane, who was then the Chair of Overview and Scrutiny, Gareth noted the Borough's call in process as an example of best practice and the details were published in the Centre for Public Scrutiny's newsletter (March 2007).

The Centre for Public Scrutiny noted the Scrutiny Call-In procedure on the Sixfield Area Action Plan (January 2006) as an example of best practice and published an article on it in its March Newsletter.

Following the recent East Midlands Local Government Association Scrutiny Network meeting, the Scrutiny Officer at Gedling Borough Council was keen to receive a copy of the Overview and Scrutiny Rough Sleepers Review report. Northampton Borough Council's Scrutiny Officer has offered the review was carried out should Councillors at Gedling feel this will be worthwhile.

Copies of the Borough Council's Overview and Scrutiny Co-Optee Guidance Booklet were requested by the London Borough of Tower Hamlets. The London Borough of Tower Hamlets' Scrutiny Officer was writing a briefing note on encouraging the involvement of co Optees in the Scrutiny process. The Scrutiny Manager at the London Borough of Merton asked for a copy of the Borough Council's Overview and Scrutiny Toolkit as she was keen to have sight of the employee's guidance note contained in the Toolkit.

The Overview and Scrutiny Co Optees Guidance Booklet has been highly praised by all co-opted members to the Overview and Scrutiny Task and Finish Groups.

Centre for Public Scrutiny (CfPS)'s Fifth Annual Conference

Councillor Malpas (Chair of Overview and Scrutiny Committee 2) and T Tiff, Scrutiny Officer, attended the CfPS's fifth Annual Conference on 13 June 2007. The conference was designed to bring together non-executive scrutineers and practitioners from across the public services to look at how effective accountability can lead to improved service delivery and drive efficiency savings across local public services. Attendees shared learning with experts and peers from their service area and across the public sector, whilst gaining insight into the common principles of scrutiny to ensure public governance works in practice.

Both attendees agreed that being at the CfPS Fifth Annual Conference was considered to be helpful and beneficial by both attendees. The information, both orally and written, that was provided was both informative and useful

During April 2006, the Chair of the previous Overview and Scrutiny Committee and the Scrutiny Officer attended East Derbyshire District Council and Chesterfield Borough Council's high profile launch of its 'Partnership Development and Evaluation Handbook', which had been produced as part of their review of partnerships and sharing success. Upon recommendation from the Chair, the Council purchased copies of the handbook to help to assess the Council's role and contribution to existing partnerships. The Policy Section at the Borough Council is currently using this handbook and a copy has also been forwarded to the Policy and Performance Manager at Northamptonshire Local Area Agreement (LAA) Partnership regarding possible use in evaluating LAA partnerships.

Local Democracy Week

As part of Local Democracy week, an event will be held at the Guildhall on Saturday 13 October 2007 between the hours of 10am and 4pm. The Overview and Scrutiny Management Committee will host a stand and a workshop at the event, detailing the work of Scrutiny.
