# Task and Finish Groups



The Overview and Scrutiny Committee sets up time limited Task and Finish Groups to carry out important reviews, which will make focussed valuable, recommendations to the Cabinet.

All Non-Executive Councillors can put themselves forward to join Task and Finish Groups to review issues of interest and importance and inform critical policy development.

Two further Task and Finish Groups Allotments (Water Charges) and Tree Policy have completed their investigations and Cabinet accepted all of the recommendations made in the Allotments (Water Charges) Task and Finish Group's final report. The Tree Policy Task and Finish Group's final report will be presented to cabinet on 19 December 2006.

# **Monitoring Overview and Scrutiny Reviews** 2005/2006

The Overview and Scrutiny Committee monitors the implementation and effectiveness of the recommendations made in Task and Finish Groups' reports at future meetings. The timetable is detailed in the Overview and Scrutiny Monitoring Work Programme 2006/2007.

#### **Planning Task and Finish Group**

This Task and Finish Group made a number of recommendations to Full Council which are aimed at increasing public satisfaction with both the Planning Committee and the Council's website.

A progress report on the implementation of the key recommendations contained in the report was detailed in the summer edition of the Scrutiny newsletter.

The Portfolio Holder for Local Environment attended the Overview and Scrutiny Committee on 4 October 2006 and provided details of the key

recommendations that have been implemented and a progress report on those yet to be implemented:

Improvements that have been made: -

- Staff keep a general watch for anyone who looks unsure or bewildered at the Planning Committee and offer advice.
- The Chair now announces any items withdrawn at short notice at the start of the meeting.
- Microphones are available to the public so that all members of the Committee can hear what they are saying as well as the public who sit behind them.
- Alternative venues to hold Planning Committees are being piloted and customer feedback sought.
- Planning Committee agendas are now bound in a more professional manner and the meeting dates are advertised on the inside of the front cover, rather than at the rear.
- The Protocol for the meeting is printed on the inside front page of the agenda outlining who can speak, for how long and how business is conducted.
- Those registered to speak are informed verbally of the Protocol prior to the meeting.
- The Council's website indexes planning applications in alphabetical order, by street name and by postcode.
- The Portfolio Holder will attend the Overview and Scrutiny Committee on 27 March 2007 and provide a progress report on the recommendations yet to be implemented.

# Outcomes of Reviews 2006/2007

# Allotments (Water Charges) Task and Finish Group

The Overview and Scrutiny Task and Finish Group was set up because a motion was put forward and carried at Full Council on 22 May 2006 that asked for a time limited Scrutiny investigation to be undertaken for the proposed water charges for allotment holders within the Borough.

The review was a short, focussed piece of work that linked to the Council's corporate priorities and examined a range of information. The Task and Finish Group looked at water usage on allotment sites within the Borough of

Northampton, water costs were investigated, as were other Local Authorities allotment rental and water charges. Site visits to various allotments within the Borough took place, interviews with the Portfolio Holder (Community Engagement and Democratic Services) and senior staff from Northampton Borough Council were held, baseline information was received and desktop research carried out using the Internet.

This review was carried out between July 2006 and September 2006.

The report and its recommendations were well received and accepted by Cabinet at its meeting on 16 October 2006. The Overview and Scrutiny Committee will monitor the implementation of the recommendations at a future meeting.





# Tree Policy Task and Finish Group

The Task and Finish Group was set up because the Overview and Scrutiny Committee was unclear whether the Council has a Tree Maintenance Policy. One of the previous Overview and Scrutiny Committees had looked into this but the work had not been finished. The aim of this review was to investigate the need and purpose of such a Policy.

The review examined a range of information. It looked at what the needs were within the Borough of Northampton and the resources it had, it also looked at Tree Policies from other Local Authorities. There was a site visit to Kingsthorpe Recreation Ground, interviews were held with senior staff from Northampton Borough Council, baseline information was received and desktop research carried out using the Internet.

This review was carried out between June and August 2006.

The report will be presented to Cabinet at its meeting on 19 December 2006.

# Housing Repairs Task and Finish Group

The Overview and Scrutiny Committee agreed that as it was felt that this review could not be completed in the allocated timescale, that it be suspended to a later date.

Although the Housing Repairs review has been suspended, it was agreed at the recent Overview and Scrutiny Committee that the tenant consultation events scheduled for 25 January 2007 from 4.15pm to 6pm and 6.30pm to 8pm at the Guilhdall be held.

# Leisure Services Task and Finish Group

This Task and Finish Group is reviewing the objectives of Leisure Services, to the extent to which the Service meets these objectives and whether the Service provides 'value for money.' A representative from the University of Northampton has been co-opted onto this Task and Finish Group to provide valuable expertise and knowledge in the subject being reviewed.

The Task and Finish Group has interviewed key front line staff, carried out desk top research, looked at models of good practice, and gathered statistical information and data. This information will contribute to the Task and Finish Group's final report which will be presented to the Overview and Scrutiny Committee at its meeting on 27 March 2007.

## Homelessness (Rough Sleepers) Task and Finish Group

During the Homelessness review (March 2006), the issue of rough sleepers was investigated and the need for a further Task and Finish Group to investigate rough sleepers had been identified.

The Group held its initial scoping meeting in November and is looking to further develop the multi agency approach to rough sleepers with a view to reducing/eliminating rough sleeping in Northampton.

This information will contribute to the Task and Finish Group's final report which will be presented to the Overview and Scrutiny Committee on 27 March 2007.

#### Street Scene Task and Finish Group

This Task and Finish Group is reviewing the poor performance indicators on the collection of abandoned cars and reviewing the new legislation, Clean Neighbourhoods and Government Act 2005, and how it will impact on this Council, particularly in relation to dealing with problems of side waste and litter left following refuse collection and whether appropriate resources are available.

The Group held its initial scoping meeting in November and. Two local residents have been co-opted onto this Task and Finish Group to provide beneficial knowledge in the subject being reviewed.

The Group is scheduled to present its conclusions to the Overview and Scrutiny Committee on 27 March 2007.

#### Community Safety (Evaluation of Dispersal Orders) Task and Finish Group

This Task and Finish Group will be evaluating dispersal orders and is due to hold its initial scoping meeting to decide on the evidence that should be gathered to inform its review.

This information will contribute to the Task and Finish Group's final report which will be presented to the Overview and Scrutiny Committee on 27 March 2007.
